**LOCAL RULE 1007-1 (b)** All creditor lists shall include the creditors' usual mailing addresses, including streets and numbers, or post office box numbers and zip codes.

**RULE 9036** was amended to allow clerks and parties to provide notices or to serve documents (other than those in Rule 7004) through the Court's electronic filing system on registered users of the system. It also allows service or noticing on any person by any electronic means so long as the person consented in writing to receive notices or service electronically. The service or notice is complete upon filing or sending, but it would not be effective if either the filer or the sender learns that it was not received.


