## Plaintiffs Must Promptly File Their Proof of Service After Serving Summons, Complaint and Pretrial Order

The Court will process and docket the Summons and Preliminary Pretrial Order. Plaintiff's attorney will receive the Notice of Electronic Filing. The Complaint, Summons, and Preliminary Pretrial Order must be served within 7 days of the date the Summons was issued (FRCP 4(e)). Proof of service must be promptly filed with the Court.
