

File Exhibit List as Main Document & Exhibits as Attachments

Filers must use the WIWB Local Form for the exhibit list. The form can be found on *the Court's website* or link to from the *ECF User's Manual* page regarding exhibits.





Exhibits must be filed electronically and must be indexed similar to paper copies. When filing the exhibit list (*Main Document*) and the exhibits in the system, each exhibit shall be filed as a separate attachment to the exhibit list. When filing attachments, remember to name the attachment. This is done in the Description field (e.g. Exhibit A, Memorandum of Law, Brief). Exhibits filed electronically are not a sufficient substitute for paper copies of exhibits used by the judge during the conduct of a final hearing or trial.
