On January 23, 1991 the debtors, John W. and Rachel J. Dolezalek, filed a chapter 13 bankruptcy petition. At the May 6, 1991 hearing on confirmation of the debtors' plan the trustee, William A. Chatterton, objected to the Dolezaleks' eligibility to be debtors under chapter 13. With respect to eligibility under chapter 13, 11 USC § 109(e) provides:

Only an individual with regular income that owes, on the date of the filing of the petition, noncontingent, liquidated, unsecured debts of less than \$100,000 and noncontingent, liquidated, secured debts of less than \$350,000, or an individual with regular income and such individual's spouse, except a stockbroker or a commodity broker, that owe, on the date of the filing of the petition, noncontingent, liquidated, unsecured debts that aggregate less than \$100,000 and noncontingent, liquidated, secured debts of less than \$350,000 may be a debtor under chapter 13 of this title.

Mr. Dolezalek represented at the confirmation hearing that the U.S. District Court for this district had relieved him of the obligation to pay to the Internal Revenue Service a sum in excess of \$119,000; however, a review of the District Court's file disclosed no order supporting Mr. Dolezalek's contention. The trustee's objection to the Dolezaleks' eligibility under chapter 13 has not been rebutted, and their chapter 13 petition must accordingly be dismissed.
